- 1. RULES AND REGULATONS: Lake of the Woods Camp for Girls and Greenwoods Camp for Boys, including the Glen and The Grove are operated solely by Lake of the Woods Operating Company, LLC. A wholly owned subsidiary of CampGroup, LLC (hereinafter collectively referred to as "Camp"). Participants of Family Camp agree to abide by all of the rules and regulations established by Camp.
- **2. FAMILY CAMP RATES & FEES:** Adults are \$595, children ages 5 17 are \$525, children 4 and under are free. Fees including lodging, all activities with instruction, meals & taxes. A 10% discount is offered to families renting a cabin with 4 or more adults.
- **3.** LINENS Linens may be rented for an additional \$15 per person for the week.
- **4. BABYSITTING:** Babysitting services are provided in your cabin at an additional charge of \$12/hr for 1-2 children and \$15/hr for 3 or more children.
- **5. DEPOSIT:** Registration is not accepted unless accompanied by a deposit of \$500, which is refundable until March 1, 2019.
- 6. BALANCE: Balance of fees is due on or before June 30, 2019 at which time it is non-refundable.
- **7. REFUNDS:** No refund is made for late arrival or early departure, except for illness or conditions which are beyond the care of the camp. The camp and the family will split a pro-rated refund in case of such circumstances.
- **8. DISPUTES:** *Choice of Venue* All claims, disputes or legal action of any kind including causes of action related to injury to person or personal property, asserted by Camper or Parent against Camp or its employees arising from or related to this agreement or any services provided by Camp shall be brought and maintained in the Courts of the State of Michigan and more specifically, in Van Buren County Michigan and Parent expressly submits to the jurisdiction of such courts.

Choice of Law – The substantive law of the State of Michigan will govern all such disputes without regard to conflict of law rules.

Fees – Any individual bringing legal action related in any way to this agreement or services provided by Camp, against Camp or its employees, which action is decided in favor of Camp or its employees will be responsible for all legal fees, court costs and out of pocket expenses incurred by Camp or its employees including its owner.

- 9. BELONGINGS: Camp is not responsible for Camper's belongings or equipment while in transit or at Camp.
- **10.IMAGES, ETC:** Permission is hereby given for Camp to use in promoting the Camp and in other ventures directly relating to the Camp (i) digital, photographic, video, and audio images or likenesses of camper; and (ii) statements, articles, names, music, art, photographs, audio recordings, films and videos created by Camper or originating from Camp.
- **11.LIABILITY:** Family Camp participants waive, and discharge Camp, including its employees and officers from liability from all and any claims resulting from the inherent risks of Camp activity.
